DEADLINE TO ENTER: EMAIL Jeri McDonald at jerim@jerimfineart.com by AUGUST 31, to sign up and receive entry form and artist profile form in pdf format. Deadline may be extended if space permits after this deadline.

NUMBER OF WORKS: Up to 3 entries at \$25 per painting or 3 painting entries for \$60. Check or cash to enter. All **2-D art** in any medium is acceptable. Maximum size: 36"x36"/25 lbs or less. All entry fees will be used to cover the costs of this exhibit and future exhibits. No refunds.

SHOW/EXHIBIT DATES: Art Show will be on **September 30, 2023 from 9:00 a.m. to 4:00 p.m.** Artwork must remain in the exhibit for (1) one month after the initial art show, **Sept. 30 through Oct. 30.**

ARTWORK SUBMISSION: Artworks must be submitted at Caldwell Banker, 2130 Main Street, Ramona, CA 92065 on **September 16 from 10 a.m. to 1:00 p.m.** Labels must be filled out and attached to the back of each piece of art. **Bring your copy when you drop off your art so we can stamp it paid as a receipt. You must have your copy in order to pick up your work after the event.**

Local artists from Ramona are preferred but not mandatory. Ramona scenes are preferred, but other subjects are allowed. We want to show as many artworks by local community artists but surrounding areas are welcome too.

RECEIVING PAYMENT FOR SOLD ART: We recommend each artist create their own Venmo or Paypal account and generate a QR code to attach for each painting. Payment can also be received directly through contact with the artist. A profile sheet with artist bio, contact and payment information must be submitted along with the entry form.

Original artwork only. Offensive subject matter will not be allowed. This is not a juried show, however artwork will be accepted at the discretion of the organizers.

Insurance for your work is the responsibility of each artist. Caldwell Banker or any of their business associates/employees and the art show organizers, are not responsible for loss or damages to any submitted artwork pieces. Sales tax will not be collected by RVPAP organizers.

All Artists are asked to attend the art show for at least an hour on **September 30.** We request that you invite at least 3 people or more.

FRAMING RULES: Artwork must be ready to hang and framed professionally. 1-1/2 inch gallery wrap unframed is acceptable but must be painted on all 4 sides. Acceptable hangers are flat D-ring hangers with tape or sleeves over wire ends. All frames must be in good condition.

PICK UP: Art pickup **November 4, 10 am-2 pm.** 2130 Main St. Ramona. **You must bring your copy of the entry form as proof of ownership.**
